Early Years Offer 2024

1. How does the setting know if children need extra help and what should I do if I think my child may have special educational needs? – Identification

At Little Heath Nursery Playgroup you can speak to any of our staff if you have any concerns about your child. However, Hajni Michael as well as Kim Hartley are our dedicated coordinators for special educational needs and disabilities. (SENCo) Further Staff Member Leisa Thompson also holds SEN qualification and has extensive SEN experience.

If your child has an identified special need before joining our setting, the SENCOs will work with you to ensure that everything is in place (eg. special equipment, staff training, classroom organisation etc) before your child joins us.

Your child's key worker will work with SEN support to continually monitor and review your child's development and progress in the setting through the Early Years Foundation Stage (EYFS) framework.

We will work closely with other professionals such as health visitors, and other healthcare professionals to ensure that your child is given appropriate support and that we provide the very best care and educational opportunities for your child.

2. How will the setting's staff support my child?

Your child's key person will develop a strong bond with your child, and we will work with you to ensure your child is happy and settled at pre-school. Your SENCo will work to ensure that you are closely involved at all stages and will also liaise with the other professionals, whose specialised knowledge will be needed. We use WELLCOMM language assessments to support children with their language development.

3. How will I know how my child is doing?

You will be given feedback on your child's progress via our Tapesty online learning journey system. This will give you up to date observations, photos and videos of activity your child was involved during the day.

Children with additional needs are monitored in a **Targeted help** process (IEP) over a 2 circle of 6 weeks support. We also track these children's progress through IAELD tool, (Individual Assessment of Early Learning and Development) to highlight and pinpoint areas of need and progress made over time with the help of our practitioners.

You are always welcome to discuss your child's progress informally at the setting or by telephone or email: littleheathnursery@yahoo.com. We will also review progress with you via their learning journals and through parent meetings and termly summaries of your child's progress.

The regularity of formal meetings between staff and parents will depend on your child's level of need.

4. How will the learning and development provision be matched to my child's needs?

Through the EYFS we will observe and assess your child and then plan their learning and development provision based on our observations. We plan our activities to be achievable yet still challenging, suitable to each child's individual stages of development.

We will follow advice from other professionals on how to support your child's particular needs and the SENCo will ensure that training need identified and addressed for staff, where possible, to support your child's learning. We **plan**, **do**, **assess and review** the progress which we share and involve the parents in!

5. What support will there be for my child's overall wellbeing?

We will involve other professionals (e.g. health visitors, SEN inclusion officer from HCC) to ensure that we support your child in all areas of their development. For example: toilet training, and any issues regarding eating, sleeping, sensory processing etc. The pre-school is fully equipped with changing table/mats/potties etc.

There is a strong emphasis on providing a safe, homely, caring environment. We apply strategies such as organising children into mixed aged groups for snack times, where younger children are with their older peers.

If your child has any specific medical needs our staff will undergo any training – e.g. epi pen training, and we will administer any medication prescribed by a hospital paediatrician or GP after discussions and instructions from the parents. WE DO NOT ADMINISTER CALPOL, Nurofen and other non-subscription medication.

We have a behaviour management policy which outlines the procedures used at the pre-school, however, if specialist help is required to manage behaviour, we can request the support of the inclusion development officer employed by the local authority.

All staff have a positive approach to all children's individual learning and development and are sensitive to their needs. Unwanted behaviour and the testing of boundaries is often part of growing up, and we will work closely with you to put strategies in place to support and enhance your child's positive behaviours.

6. What specialist services and expertise are available at or accessed by the setting?

Hajni Michael, has 13 years of experience working with children with a wide range of needs in different settings. She is the registered person and has SENCO training. She has completed her level 3 qualification in delivering ELKLAN speech and language programmes and has a keen interest in child behaviour. She also completed a level 3 Diploma, on Child Behaviour.

Kim Hartley (SENCO) completed her level 3 Diploma in Children's Learning and Development - Early Years Educator in 2020 after working with children for many years as a child minder.

Leisa Thompson (Deputy Manager) completed her level 3 Diploma in Early Year in 2013, after working in child care for some time.

We have links with the Potters Bar PB1 Children Centre as well as our local children Centre at Furzefield. We have access to a wide range of agencies such as advisory teachers, speech and language therapists, health visitors, GPs etc.

We also have a good relationship with all the local feeder schools, and this will make the process of moving to a new setting much easier for your child. School nursery teachers are invited to our setting during the summer term as part of our transition support. Transition Data of each child leaving our setting is shared with their receiving schools.

We can signpost parents to support agencies such as SEND SAS and other support groups and forums.

7. What training and/or experience do the staff, supporting children with SEND, have?

Our Staff members completed a Makaton training in January 2023, with access to the database of Makaton signs and symbols held at the pre-school so we can look up words to support individual children.

Our SENCOs has over 8 years' experience supporting children.

8. How will my child be included in activities outside the setting?

We will discuss your child's needs with you to ensure they can be included. All parents are welcome to act as a parent helper on possible outings. Consent prior to outing is always sought.

9. How will I be involved in discussions about and planning for my child's learning and development?

Your child's key person will be available to discuss your child's needs however it may be necessary to arrange a mutually convenient time for a meeting.

If outside professionals come in to see your child, we try to organise a meeting at the end of

visit for a brief discussion. If this is not possible any reports are always copied and given to you.

Parental consent is always obtained before we refer to any outside agencies.

9. How accessible is the building / environment?

The playgroup environment is accessible and meets the current disability regulations.

There are stairs in our building, but all areas are accessible via ramps. Our main entrance is accessible via steps, however visitors and children with disabilities can enter our room via the Church Foyer, which provides stair free access.

We have tables, chairs and equipment at children's level. In our garden we have patio and soft areas where our climbing frames are located. We also have covered sand area.

We do NOT have a disabled toilet with wheelchair access, however, there is one in the main hall adjacent to the pre-school to which we have limited access.

10. How will the setting prepare and support my child with transitions between home, settings and school?

Our nursery doesn't carry out home visits, however if you wish before starting pre-school we will so our SENCO can meet your child in their home environment. If necessary, a health care plan is completed and signed off at this meeting.

Taster session will be organised at pre-school for you and your child to attend prior to their start date.

If you child receives care from any other setting (e.g. another nursery or a childminder) we will work with them by sharing learning journals on a termly basis. They can be added to the Tapestry Learning Profile, which they can access via password. They can upload messages and contribute only to your child's learning profile.

When it is time for your child to leave us to start nursery or school we will contact the new setting and invite them to visit your child at pre-school. During this visit the teacher or key person from the school will meet and play with your child and we will discuss their development and progress.

11. How will the setting's resources be used to support children's special educational needs?

All equipment and toys are moveable and can be made accessible, they are age and development stage appropriate. We will seek to borrow specific equipment needed for specific needs.

The pre-school has statutory staff/child ratio. We are an inclusive setting and have a range of resources/strategies in place to support children with a range of needs e.g. we have visual timetables and choice boards (using photographs and symbols) this may be used with speech and language delay or if English is a second language.

We have a number of sensory resources.
